#### 4. Eligibility criteria for the bidders:-

#### a) Technical Criteria:

- i) Survey work must be supervised by a civil engineer
- ii) Capable of conducting survey work only by the technically qualified personnel having qualification not below the certificate of Diploma in civil / Diploma in survey/ Draftsman
- b) Financial Criteria:

Scanned Copy of PAN card, P. Tax, Valid Income Tax return (for last 3years0, GST Certificate, Credential certificates of similar nature of works, Work Order, payment certificate and other supporting documents, Registration certificate and/or valid trade license of the company must be submitted duly digitally signed at designed location in the website<u>www.wbtenders.gov.in</u>

- c) Scanned copy of one affidavit before Notary will have to be submitted mentioning the correctness of the document and a declaration of penalty debarment etc. faced by him under any Govt./Semi-Govt./Autonomous body/ Intuition through on line at desired location and proforma of affidavit before notary in mentioned in the instruction to Bidder.
- 5. EMD ₹ 5,000.00 of the estimated amount put to tender to be deposited though online.
- 6. Refund of EMD: The Earnest Money of all the unsuccessful Tenderers deposited through the online will be refunded by the same methods (through the online)
- 7. Partnership firm should submit necessary deed at described location through online.
- 8. List of common documents shall have to be uploaded by each tenderer at the time of submission of Tender through online:

  - iii. Professional Tax Enrolment certificate with current year Challan

- 9. Language of Tender:-The tender shall be submitted in the prescribe form in English. All literature and correspondence in connection with the tenders shall be in English.
- **10. Others:-** The tender notice along with other documents like Tender form no.1 Kalyani Municipality, Technical Specification, Special Terms and conditions, BOQ Addendum and corrigendum etc. whatever documents uploaded by the department concerned thereto shall be part and parcel of the tender.
- **11. Declaration:-** Tenderer must upload and submit duly digitally signed a declaration as per prescribed format for conformation of his awareness of the contract. For any quarries related to work, the intending agency may contact the office of the undersigned.

#### 12. Scope of Work:

- i. Complete Survey with Computer data sheet, with Field Book.
- ii. Preparation of Estimate, DPR and BOQ Design of Culvert, and Drain.
- iii. Estimate and all other relevant document to be vetted by component authority.
- iv. Design of Drain section as per catchment area.
- v. Drawing for Plan, Sectional Drawing, Alignment Drawing, etc. of RL's should be given (alignment drawing is submitted with i.e from starting point and to outfall).
- vi. Drawing for drainage section and catchment area.
- vii. Mentioning details design and calculation with drawing where and how the collected water will be discharged clarify outfall details.
- viii. Submitted copy of field survey book, level book along with image of survey for the entire length of the proposed drain.
- ix. Also mentioning where it has been checked that total no. of culvert along the total length of road and corresponding any information about vehicles will be passing through the culvert.
- x. Submitted copy of the design calculation sheets for final check verification.
- xi. The invert level of the drain in given from starting to end in the Alignment Drawing.
- xii. RL's should be given taken from Kalyni Simanta Railway Station.

#### 13. Selection/ Acceptance of the successful Bid/offer:-

a) Two stage evaluation system to be followed for evaluation of the bid.

Stage 1- Qualification proposal, bidder's experience, proposed concept design and implementation proposal.

Stage 2- The bidder submitted document shall be verified with respect to eligible criteria. The bidder who meets all this submission requirements and eligibility criteria shall be allowed for stage- 2 i.e. Financial Part.

In Stage-2, the lowest quoted bidder (L1) will be successful bidder.

#### Terms and conditions:-

14. Participating firms must have ST and PT clearance certificate and IT and PAN etc valid at least up to the date of submitting their bid. Application for such clearance addressed to the competent authority, subject to production of the authenticated receipt, may also be considered.

- 15. Before submitting any bid offer, the intending participants should make themselves acquainted thoroughly with the local conditions prevailing by actual inspection of the site and take into consideration all aspect including actual size and availability of land, communication facilities; climate conditions etc. as no claim whatsoever will be entertained on these accounts, afterwards.
- 16. The selected bidder will have to enter into an agreement of contract with Kalyani Municipality within 15 days (fifteen days) of issuance of the LOI or Work Order.
- 17. The detailed report would have to be submitted by the Agency/Consultancy firm within **45 days (forty Five days)** from the date of issue of LOI.
- 18. The final report must confirm the prevailing rules of the W.B. Valuation Board.

#### 19. Fees Payable:

The Consultant would have to quote rate as below:-

- i. No work mobilization amount will be entertained.
- ii. No R.A. bill will be entertained.
- iii. The payment will be made after getting clearance from Municipal Engineers and Vetted authority.
- iv. The security money and EMD will be released after the final payment.
- 20. Any bid/offer containing overwriting is liable to be rejected. All corrections are to be attested under the dated signature of the bidder without which the bid/offer maybe informal.
- 21. Intending participants may attend the pre bid meeting as per schedule in the office of the Chairman, BOA, Kalyani Municipality.
- 22. No conditional bid/offer shall be accepted.
- 23. The bid will be valid for 45 days (forty Five days) from the opening of the financial bid.

#### **INSTRUCTION TO BIDDERS**

Instruction/Guidelines for tenders for electronics for electronic submission of tenders online have been annexed for assisting the contractors to participate in e-tendering.

**Registration of Contractor-** any contractor willing to take part in the process of e-tendering will have to be enrolled and registered with the Government e-Procurement system through logging on to <u>www.wbtenders.gov.in</u>. The contractor is to click on the link for e-tendering site as given on the web portal.

- 1. Digital Signature Certificate (DSC)- Each contractor is required to obtain a class-II or class-III Digital Signature Certificate (DSC) for submission of tender from approved service provider of the national information's Centre (NIC) on payment of requisite amount details are available as the website stated in clause 1 of Guidelines to Bidder. DSC is given as a USB e-token.
- Collection of tender documents- The contractor can search and download NIT and tender documents electronically from computer once he logs on to the website mentioned in clause 1 using Digital Signature Certificate. This is the only mode of collection of tender documents.

#### 3. Submission of tenders-

- a. General process of submission- Tenders are to be submitted through online to the website stated in clause 1 in two folders at a time for each work, one is Technical bid and one is Financial bid before the prescribed date and time using the Digital Signature Certificate.
- b. Technical Bid-Technical Bid contains scanned copies of the following further two cover (folder).
- A-1.Statutory Cover Containing:
  - i. NIT
  - ii. Declaration as per prescribed format.
- N.B.- Bidder must download Kalyani Municipality Tender Form No-1, General Terms and condition, Special Terms and conditions, technical specification, all other addendum, corrigendum etc. whatever documents uploaded by the departments in the wen under NIT and must go through carefully before quoting this rate. These documents are not necessarily be uploaded by the bidder.

#### a. Financial Bid:-

- i. The financial bid should contain the following document in one cover (folder) i.e. Bill of Quantities (BOQ). The contractor is to quote the rate through on line in the space marked rate in the quoted BOQ.
- ii. Only downloaded copies of the above documents are to be uploaded, scanned and digitally signed by the contractor.

i. Technical bid will be open first, after opening of the Statutory Cover (folder) will bid found in order and correct Non statutory Cover (folder will be opened). If there is any deficiency in the Statutory and Non Statutory documents the tender will summarily be rejected.
