### 1. Eligibility to participation in Bid.

#### 1.1. For 1st Call of NIT :

- Intending tenderers should produce credentials of a similar nature of Completed at least one work of the minimum value of 40% (forty percent) of the estimated amount during 5 (five) years prior to the date of issue of the tender notice; or,
- Intending tenderers should produce credentials of 2 (two) similar nature of completed work, each of the minimum value of 30% (thirty percent) of the estimated amount during 5 (five) years prior to the date of issue of the tender notice; or,
- Intending tenderers should produce credentials of one single running work of similar nature which has been completed to the extent of 80% (eighty percent) or more and value of which is not less than the desired value as (1.1.i.) above;  
In case of running works, only those tenderers who will submit the certificate of satisfactory running work from the concerned Executive Engineer, or equivalent competent authority will be eligible for the tender. In the required certificate it should be clearly stated that the work is in progress satisfactorily and also that no penal action has been initiated against the executed agency, i.e., the tenderer.

1.2. **Annual Turn Over**-Having average audited annual turnover at least 40% of amount put to tender in preceding three financially ears from the publication of this e-NIT.

1.3. Bank solvency Certificate not less than 40% of amount put to tender within 12 (Twelve) month prior to date of publication of this e-NIT

1.4. Above cited of more of the estimated amount of this work /supply **No private** credentials will be considered satisfactory completion certificate must have to be produced while depositing the tender.

1.5. Intending Contractors Tenderers must be financially sound and have their machineries required for the job.

#### 1.6 Other terms and conditions of the credentials:-

- Payment certificate will not be treated as credential
  - Credential certificate issued by the Executive Engineer or equivalent or competent authority of a State / Central Government, State / Central Government under taking, Statutory / Autonomous bodies constituted under the Central / State Statute, on the executed value of completed / running work will be taken as credential.
2. In the event of e-filling, intending bidder may download the tender documents from the website <http://wbtenders.gov.in> directly with the help of Digital Signature Certificate. Necessary Tender Fee and Earnest Money may be remitted through online also to be documented through e-filling.
3. Both **Technical Bid** and **Financial Bid** are to be submitted concurrently duly digitally signed in the website <http://wbtenders.gov.in>
4. Tender documents may be downloaded from website and submission of Technical Bid and Financial Bid will be done as per time Schedule stated in **Sl. No.- 7**
5. The financial offer of the prospective tenderer will be considered only if the **Technical Bid** of the tenderer is found qualified by the 'Board of Councillors of **Kalyani Municipality**'. The decision of the 'Board of Councillors of **Kalyani Municipality**' will be final and absolute in this respect. The list of Qualified Bidders will be displayed in the website.

### 6. Eligibility criteria for participation in the tender -

- 6.1 As per NIT detail table above 1. **Trade License**, 2. **PAN**, 3. **P Tax (Challan) Latest Year** 4. **IT last 3 (three) years and Latest IT Receipt**, 5. **IT-Saral for Assessment year 2023-24**, 6. **GST**, 7. **EMD Amount**, 8. **3 (three) years Annual Turn Over**, 9. **Credential**, 10. **Online payment data sheet for EMD and Paper Cost (Exemption Allowed require The Micro, Small and Medium Enterprises Certificate)**, are to be accompanied with the Technical Bid Documents.

[Non-statutory documents]

The prospective bidders or any of their constituent partner shall neither have abandoned any work nor any of their contract have been rescinded during the last 5 (five) years. Such abandonment or rescission will be considered as disqualification towards eligibility. (A declaration in this respect has to be furnished by the prospective bidders without which the Technical Bid shall be treated as non-responsive.)

Registered Partnership Deed for Partnership Firm only along with Power of Attorney is to be submitted. The company shall furnish the Article of Association and Memorandum.

### 6.2 Joint Ventures will not be allowed.

A prospective bidder shall be allowed to participate in a particular job either in the capacity of individual or as a partner of a firm. If found to have applied severally in a single job, all his applications will be rejected for that job without assigning any reason thereof.

The executing agency may not get a running payment unless the gross amount of running bill is 30% of the tendered amount whichever is less. Provisions in Clause(s) 7, 8 & 9 contained in W.B. Form No.-2911(of Kalyani Municipality) so far as they relate to quantum and frequency of payment is to be treated as superseded.

Adjustment of price in respect of construction materials shall not be applicable. The bidders shall quote their rate accordingly.

### 6.3 No mobilization advance and secured advance will be allowed.

Agencies shall have to arrange land for erection of Plant & Machineries, storing of materials, labour shed, laboratory etc. at their own cost and responsibility.

All materials required for the proposed work shall be of specified grade in conformity with relevant code of practice (latest revision) accordingly and shall be procured and supplied by the agency at their own cost including all taxes. If required by the Engineer-in-Charge, further testing from any Government approved Testing Laboratory shall have to be conducted by the agency at their own cost.

Constructional Labour Welfare CESS @ 1% (one percent) of cost of construction will be deducted from every Bill of the selected agency. There shall be no provision of Arbitration.

Bid shall remain valid for a period not less than 120 (one hundred twenty) days from the last date of submission of Financial Bid / Sealed Bid. If the bidder withdraws the bid during the validity period of bid, the earnest money as deposited will be forfeited forthwith without assigning any reason thereof.

8. The Prospective Bidder shall have to execute the work in such a manner so that appropriate service level of the work is maintained during progress of work and a period of 1 (one) year from the date of successful completion of the work to the entire satisfaction of the Authority. If any defect / damage are found during the period as mentioned above, the contractor shall make the same good at his own cost to the specification at par with instant project work. On failure to do so, penal action against the contractor will be imposed by the Department as deem fit. The contractor may quote his rate considering the above aspect. Refund of Security Deposit will only be made after successful maintaining of appropriate service level of the work as mentioned above for 1 (One) year from the date of completion of the work. Provision in Clause No. 17 of Form No. -2911(ii) (Kalyani Municipality Form No. -2911 (ii)) shall be treated as superseded.
9. Site of work and necessary drawings may be handed over to the agency phase wise. No claim in this regards will be entertained.
10. EMD 2.0 % of the estimated amount put to tender to be deposited though online.





11. The Bidder, at his own responsibility and risk is encouraged to visit and examine the site of works and its surroundings and obtain all information that may be necessary for preparing the Bid and entering into a contract for the work as mentioned in the Notice Inviting Tender, before submitting offer with full satisfaction, the cost of visiting the site shall be at his own expense.
12. The intending Bidders shall clearly understand that whatever may be the outcome of the present invitation of Bids, no cost of Bidding shall be reimbursable by the Department. The tender accepting authority of **Kalyani Municipality** reserves the right to accept or reject any offer without assigning any reason whatsoever and is not liable for any cost that might have been incurred by any Tenderer at the stage of Bidding.
13. **Refund of EMD:-**
  - i) The Earnest Money of all the unsuccessful Tenderers deposited through the online will be refunded by the same methods (through the online)
  - ii) The payment will be made as and when fund is available from the concerned source. No claim what so ever for delay in payment, if any, will be entertained. Retention money towards performance Security amount to 8% (eight percent) of the value of the work will be deducted from the running account bill of the tender as per prevailing order. Earnest Money (EMD) @ 2% of the estimated value put to tender would be converted to Security Deposit in case of the successful bidder. No interest will be paid on security deposit

14. Prospective applicants are advised to note carefully the minimum qualification criteria as mentioned in 'Instructions to Bidders' stated in Section - 'A' before tendering the bids
15. **Conditional / Incomplete tender will not be accepted under any circumstances.**
16. **The intending Tenderers are required to quote the rate online.**
17. Contractor shall have to comply with the provisions of (a) the contract labour (Regulation Abolition) Act. 1970 (b) Apprentice Act. 1961 and (c) minimum wages Act. 1948 of the notification thereof or any other laws relating thereto and the rules made and order issued there under from time to time.
18. **Guiding Schedule of Rates:-** Rates have been taken from **PWD (WB), Schedule of Rates : 2018, Volume III : Road & Bridge Works, (latest addenda corrigenda)** and P.W.D./P.H.E. 19. During scrutiny, if it comes to the notice of the tender inviting authority that the credential or any other paper found incorrect /manufactured / fabricated, that bidder would not be allowed to participate in the tender and that application will be rejected without any prejudice.
20. The Chairman, Kalyani Municipality reserves the right to cancel the N.I.T. due to unavoidable circumstances and no claim in this respect will be entertained.
21. If there be any objection regarding prequalifying the Agency that should be lodged on line to the Chairman i.e. Tender Inviting Authority within 2 (two) days from the date of publication of list of qualified agencies and beyond that time schedule no objection will be entertained by the Tender Inviting Authority.
22. Before issuance of the **WORK ORDER**, the tender inviting authority may verify the credential and other documents of the lowest tenderer if found necessary. After verification if it is found that the documents submitted by the lowest tenderer is either manufactured or false in that case work order will not be issued in favour of the said Tenderer under any circumstances.

24. **Qualification criteria:**

The tender inviting and Accepting Authority will determine the eligibility of each bidder. The bidders shall have to meet all the minimum criteria regarding:

  - 1) Financial Capacity
  - 2) Technical Capability comprising of personnel & equipment capability
  - 3) Experience / Credential

The eligibility of a bidder will be ascertained on the basis of the document(s) in support of the minimum criteria as mentioned in (a), (b) & (c) above and the declaration executed through prescribed affidavit in non-judicial stamp paper of appropriate value duly notarized. If any document submitted by a bidder is either manufactured or false, in such cases the eligibility of the bidder/tenderer will be rejected at any stage without any prejudice.
25. **Defect Liability Period:-**

As par Notification No.5784-PW/L&A/2M-175/2017 dt.12.09.2017 of Principal Secretary, PWD and relevant clause of Form no. 2911(Municipal Tender Form).

For this work defect liability period is 3 years from the date of completion of the work as per completion certificate issued by the Chairman, Kalyani Municipality. However, completion certificate should be issued after completion of all items of works as per schedule as required including supplementary items (if any) in all respect.





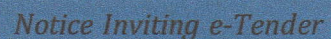
