The successful Tenderer (as Licensee) will be entitled to deposit the monthly amount (The Bid Money) of Projection of film always in advance to the office of the Kalyani Municipality throughout the entire period of Licensees.

The successful Tenderer (As Licensee) will have to deposit Security money tantamount to 15 days bid money (before the execution of Deed of Licensees) in the shape of Demand Draft in favour of the Chairperson, Kalyani Municipality which will be lying with the Chairperson, Kalyani Municipality for the entire period of Licensees and also that shall be liable to be forfeited to the Municipality, if the successful Tenderer (as Licensee) fails to pay monthly bid money (in advance) for every month or for any sort of breach of contract.

The successful tender (as Licensee) will also have to execute deed of Licensees agreement with the Chairperson, kalyani municipality on Rs. 10/- stamp for the original copy of the deed. Upon getting the letter of acceptance within 10 (Ten) days from the date of issue of letter of acceptance the Tenderer has to execute the said deed of Licensees agreement at the cost of Tenderer otherwise earnest money submitted by him/ them forfeited.

The Licensees condition will be prescribed by the Chairperson, Kalyani Municipality as per enclosed in compliance performa with due and faithful observation of provisions of law under West Bengal Municipality Act. 1993 as amended up to date. The Licensees deed along with all terms and conditions of the bid will form a part of the contract and the successful Tenderer (as Licensee) shall be bound himself/themselves to abide by the same.

The successful tenderer will have to deposit Income Tax @ 2% on the amount of bid offered and accepted by the Municipality in addition to his/their offered bid value per month during the entire period of contract.


The successful tenderer will must submit proposed establishment (manning chart) for smooth functioning of the Film Projection work.





TERMS AND CONDITIONS

1. The Licensees shall remain valid for a period of 2 (Two) year to be counted from the date of commencement.
2. Selection of the Licensee shall be on the basis of Quoted Bid as said in the Tender of the Chairperson Normally the highest Bidder will be selected by the Chairperson, Kalyani Municipality. But the accepting authority has the right to accept the highest Bid or any other bid or to reject all of them without assigning any reason.
3. The successful Bidder (whose offer bid shall be accepted) shall have to pay in advance a Security Deposit equivalent to bid money for 15 (Fifteen) days as stated in the Tender of the Chairperson, Kalyani Municipality. The successful Bidder (as Licensee) will have to execute deed of Licensees with the Chairperson the on (as Licensee) on requisite stamp Rs. 10/- and in compliance with other particular as mentioned in Tender of the Chairperson and the said deed of Licensees shall have to be executed within 10(Ten) days from the date of issue of Letter of Acceptance, failing which earnest money of the bidder lying with the Department will be forfeited.
4. Upon selection of Licensee and receipt of requisite Security by deposit from him and execution of the aforesaid deed of Licensees agreement, the Chairperson concerned or his representative shall hand over the **Projection of film and other Cultural activity at Vidyasagar Mancha under Kalyani Municipality**, Kalyani, Nadia to the Licensee.
5. The Licensee will deposit One Month bid money along with 2% thereof as Income Tax (TCS) in advance in every month in the manner as described.
6. The Licensee shall stand terminated with forfeiture of Security Deposit, if the bid money for any particular month is not deposited in advance with Kalyani Municipality concerned with 24 hours, from the specified day of month.
7. Chairperson, Kalyani Municipality reserves the right to terminate the contract at any time without assigning any reasons to the Licensee whatsoever, on receipt of the order in this regard, the Licensee shall have to hand over the **Projection of film and other Cultural activity at Vidyasagar Mancha under Kalyani Municipality**, Kalyani, Nadia to the Chairperson, Kalyani Municipality.
8. The all liabilities of staff arrangement for **Projection of film and other Cultural activity at Vidyasagar Mancha under Kalyani Municipality** will be with Licensee. The Kalyani Municipality authority will not take any responsibilities for the staffs of Licensee.
